

Non-accounting services through separate company

CPPs are now able to provide non-accounting services through separately formed limited liability companies (LLC).

The Council had considered applications from some CPPs earlier this year for providing non-accounting services through a separate legal entity that is independent of the accounting firm or practice.

"The Council, comprising only the non-CPP members, considered the matter in light of the provisions of the FIA Act, FIA Rules and, FIA Supplementary Code of Ethics governing the members and sought legal advice," said FIA President Divik Deo.

"The process took close to two months to complete," he said.

"Certain operations which are not regular accounting or auditing functions may be undertaken through the LLCs with consent from the Council", said Deo.

He said all applications for consent will be considered on a case-by-case basis by the Council.

Each applicant must provide the memorandum and articles of association, list of shareholders and directors, and details of the exact nature of the services, of the proposed company.

"These are consistent with the Institute's Supplementary Code of Ethics Article 4 ('SCOE4')," said Deo.

"The proposed services must not provide or purport to provide accounting services within the meaning of Section 6.4(a) of the FIA Rules, example preparation of financial statements, auditing, taxation and, insolvency."

"The Council may give an applicant 'no objections' consent for the company to offer the approved services to the public," said Deo.

"The no objections consent is to ensure that it is understood that FIA does not absolve the company from complying with the fundamental rules of the profession and all other laws and regulations in force in Fiji," he said.

The Council will have the right not to approve any application that does not contain sufficient details relating to the proposed services.

Deo said that only current CPP holders could be shareholders of the proposed company.

He said that the independence requirements under Section 290 of the IFAC Code of Ethics 2010, would always apply to CPPs providing the approved services.

The Council approved the following broad, non exhaustive, list of services which may be provided by a company:

- Temporary staff assignments
- Management responsibilities
- Valuation services
- Internal audit services except financial audits
- IT systems services
- Litigation support services
- Recruiting services

Vacancies on Council

The Council will have three vacancies when some of the members retire at the next AGM to be held on 8th June 2012 at the Sheraton Fiji Resort. Tessa Mackenzie, the Acting Executive Director said that Sikeli Tuinamuana, Divik Deo and, Camacakau Raimuria will be retiring after three consecutive years of service on the Council. "Every member who retires shall be deemed to be duly nominated for re-election unless he or she wishes not to offer himself or herself for re-election", said Tessa. "However, this did not preclude further nominations from being lodged and nomination forms for election to the Council must be lodged with the FIA 14 days before the AGM,"she said.

Former FIA President and Business Consultant Deo Saran has been engaged by the Council to review the FIA Corporate Plan. Saran met with various committee chairs last week and is very pleased with the response.

"I wish neither to re-invent nor to do a desk top review," said Saran.

He said that he wanted to assess FIA and the accounting profession in Fiji, IFAC and the Statutory Membership Obligations and gauge the Council's expectations from which he will produce recommendations.

Saran said that the membership was now younger, with different expectations and that new committees may be needed. He also noted that ethics, advocacy, and increasing members' participation in FIA activities needed

Academics now eligible for CA status

The Council may now grant CA status to academics after recommendations from the Education, Membership and Awards Committee.

Committee Chairperson Lisa Apted said they explored the practice of admitting academics by CPA Australia, NZICA and ICAA after receiving enquiries.

The Council may approve applications from academics if the following requirements are satisfied: the applicant must hold a Doctorate or at least Masters Degree in Accounting or allied subject; have held a position

of lecturer or more senior post at an accredited tertiary institute, teaching undergraduate or postgraduate courses, required for FIA admission for chartered accountant, for at least 5 years; have taught a range of courses including at least 3 of the 6 categories of practical experience (Auditing, External Reporting, Insolvency and Reconstructions, Management Accounting, Taxation, Treasury) certified by a senior academic.

Nitin Gandhi, the Chairperson of the Corporate Plan Committee, said that the Council had agreed that the relevance of the plan was important and the need to take into account changes in the role of accountants, the context, and legislation.
