Legislative Framework



The Accident Compensation Act 2017

Came into force from 01 January 2018

Regulations

- Accident Compensation Regulations 2017
- Accident Compensation (Levies) Regulations 2017
- Accident Compensation (Medical Assessment) Regulations 2017
- Accident Compensation (Amendment) Regulations 2018
- Accident Compensation (Employment Accidents) Regulations 2018
- Accident Compensation (School Accidents) Regulations 2018

The AC Act covers all motor vehicle accidents occurring on or after <u>1 January 2018</u>.


From 1 January 2019 ACCF compensates for employment and school injuries and deaths.

The Act provides for a 'no fault compensation scheme'

Coverage extends beyond *third parties* i.e. any personal injury or death suffered by any person as a result of an accident in Fiji is eligible for compensation under the Act.

Passenger liability in buses limited to an amount considered not adequate in today's dollar (\$40,000 for each accident; \$4,000 for each passenger)

Motor Vehicle Accidents




ACCF has been receiving applications for compensation for motor vehicle accidents since 1st January 2018. As at 12th March 2019:

What's New Since 1st January, 2019

 From 1 January 2019 workers and pupils will be compensated for injuries, deaths and any incident that causes a prescribed disease as a result of employment or school accidents.

 Workmens Compensation Act needed to be updated and made more victim friendly.

• The Accident Compensation (Amendment) Regulation 2018 provides for compensation on a no fault basis.

Maximum compensation amounts are higher under the new scheme.

Employment Accidents



Who is Entitled to Claim Compensation for Employment Accidents?


• All workers will be entitled to compensation for injuries as a result of an accident <u>arising out of and in the course of employment</u> from 1st January 2019. This includes any incident that causes a prescribed disease. In the case of the death of a worker their personal representative is entitled to make an application on the deceased workers behalf.

• A worker means any person who has entered into or works under a contract of service or apprenticeship with an employer.

Employers Duty to Report

- If a "worker" suffers any personal injury as a result of an accident arising out of and in the course of employment, the workers employer must report the accident to the Permanent Secretary responsible for employment and ACCF within 14 days from the date the employer becomes aware of the accident and injury (ACCF Form 1).
- If a "worker" dies as a result of an accident arising out of and in the course of employment, the workers employer must report the death of the worker to the Permanent Secretary responsible for employment and ACCF within <u>7 days</u> from the date that the employer becomes aware of the accident and death (ACCF Form 1).

Duty to Pay Two-Thirds Weekly Earnings

• If a "worker" suffers any personal injury as a result of an accident arising out of and in the course of employment, the workers employer must pay the worker a weekly payment of two-thirds of the weekly earnings which the worker was earning at the time of the accident.

• The maximum duration of two-thirds weekly payments must not exceed 260 weeks. It is the employers duty to make these payments.

• An employer may elect to dispute the duty to pay the weekly payment by making an application to the Permanent Secretary for Employment only on the grounds that the accident did not arise out of and in the course of employment.

Do Employers Have to Pay a Levy to ACCF

• Employers do not have to pay a levy to ACCF.

• Funding for the scheme is being sourced from the 1% FNU Levy.

• Employers need to continue paying the 1% FNU levy. A Compliance letter from the Levy and Grants Department at FNU must be obtained after paying the levy.

• If the employer is exempt from paying the levy then an exemption certificate must be obtained.

School Accidents




- From 01 January 2019 all pupils will be entitled to compensation for injuries and death as a result of an accident occurring on any school premises or during a school event or activity.
- "School accident" means an accident that occurs-
- (a) On any school premises during normal school hours; or
- (b) At any venue during a school event or activity; and

"School premises" includes any school building, office, classroom, workshop, dormitory, hostel, kitchen, clinic and any play area or playground within the school compound.

• In the case of the death of a pupil their personal representative is entitled to make an application on the deceased pupil's behalf.

School's Duty to Report

- If a pupil suffers any personal injury as a result of a school accident, the **controlling authority** of the school must report the school accident and injury to the Permanent Secretary responsible for education and ACCF within **14 days** the date that the controlling authority becomes aware of the school accident and injury (ACCF Form 1).
- If a pupil dies as a result of a school accident, the <u>controlling authority</u> of the school must report the death of the pupil to the Permanent Secretary responsible for education and ACCF within <u>7 days</u> from the date that the controlling authority becomes aware of the school accident and death (ACCF Form 1).

Notification of School Accidents

In the event of personal injury/ death/ occupational disease from a <u>SCHOOL</u> <u>ACCIDENT, ACCF Form 01</u> is to be completed and addressed to:

The Accident Compensation Commission Will Not Consider The Following Applications:

 The applicant refuses to provide information as required by the ACCF;

 An application for a person who refuses to undergo medical assessment;

A fraudulent application; and

An application that has been previously determined by the ACCF.

Exclusions

• Driving under the influence of alcohol over the prescribed limit or under the influence of drugs;

 Failing or refusing to permit a breath test or a specimen of blood to be taken;

 Not holding a valid driving license authorising that person to drive the motor vehicle of the class or use for which it is registered;

Failure to comply with all the conditions of the driving license;

Being convicted for any act or omission that directly caused the accident;

Exclusions

Any injury or death that did not directly arise from the accident;

 Owner of a vehicle who, failed to pay the Motor Vehicle Accident levy;

Deliberate self-injury;

• Attempted suicide or suicide.

How Much Compensation Is Paid?

Maximum Payments

Permanent Partial Incapacity \$75,000

Permanent Total Incapacity \$150,000

Any other cases (other than the above) \$75,000

Death \$75,000

Who Can Apply for Compensation

Person Suffering from Mental Disorder	Legally appointed representative

How To Apply For Compensation

 Application forms are available at any LTA Office and the ACCF office in Valelevu, or the ACCF website www.accf.com.fj

• Fill in an application form and provide the required information.

• Provide certified true copies of photo ID (applicant & injured person, if applying for somebody else) e.g. joint card, drivers license & passport photo, police report, medical report, birth certificate, death certificate (if applicable), TIN number (if no joint card), bank statement, Probate or Letters of Administration (if applicable) and other pertinent information.

Key Provisions

- Limitation period 3 years.
- 28 days to accept offer of compensation.
- Acceptance of compensation to be bar to any proceeding.
- Applicant may decline offer and commence proceedings under common law.
- Parties to proceedings to serve any claims on ACCF. Anyone who is sued must not enter into any settlement negotiations, without the consent of ACCF.
- ACCF must satisfy any judgement from those proceedings.
